MARCH OF DIMES NAMES BUFFALO ROCK CHAIRMAN AND CEO JAMES C. LEE, III 2011 CITIZEN OF THE YEAR

Lee to be Honored at 18th Annual Recognition and Testimonial Event

BIRMINGHAM, Ala. – James C. Lee, III, Chairman and CEO of Buffalo Rock, has been named the March of Dimes 2012 Alabama Citizen of the Year. Lee will be honored at the 18th Annual March of Dimes Alabama Citizen of the Year Testimonial Reception Tuesday, Nov. 13, 2012 at B & A Warehouse in Birmingham. Lee and his group of Mission Chairs have set a goal of raising \$325,000 for March of Dimes over the next few months.

The March of Dimes Alabama Citizen of the Year honors an outstanding citizen of Alabama whose distinguished leadership and devoted service to the community have contributed greatly to the quality of life for Alabama and its people. The recipient is a person who, in the victory of achieving success and acclaim, has given back generously to others. The Alabama Citizen of the Year event has raised almost \$2 million for the March of Dimes.

"We truly feel that Mr. Lee embodies every aspect we look for in a Citizen of the Year honoree distinguished leadership, devoted service to the community, and giving back generously to others. As a fourth generation Lee and Buffalo Rock owner, Jimmy is following in his family's footsteps by contributing greatly to the quality of life for Alabama and its people," says Senator J. T. "Jabo" Waggoner, March of Dimes Board Member and event chairman. "We can think of no one more deserving to receive this distinguished award this year than our chosen recipient."

James C. Lee, III ("Jimmy"), currently serves as Chairman of the Board and CEO of Buffalo Rock Company, the largest privately-held, single-family owned Pepsi-Cola franchise in the United States. Jimmy is the fourth generation Lee to take over the business. Buffalo Rock began in 1901 and currently employs over 2,100 employees in the Corporate Headquarters Facility and fourteen different locations across Alabama, Georgia and Florida. Serving over 6.5 million people, the company provides wholesale beverage and snack sales, full-line vending and catering services.

Jimmy's career with Buffalo Rock Company began at age 12, where he worked in the summer. Jimmy graduated from Auburn University in 1970. He spent one year working with Pepsi-Cola Company, then began working full time at Buffalo Rock Company in 1971.



A Birmingham resident and fourth generation Lee, Jimmy's efforts are concentrated toward community involvement. With his encouragement and support, Buffalo Rock makes significant contributions to the community through sponsorship of charitable events, including donations of time, services and product. Jimmy devotes a significant amount of his time to a long-term civic project with Bent Brook Golf Course. The facility is the first privately-owned public course in Birmingham that offers residents another alternative for public golf.

He currently serves as Vice Chairman on the board of Children's Hospital of Alabama, as well as Past President of the Vestavia Park Foundation, Past President of Children's Hospital Foundation Board, Past Board Member of the American Beverage Association, and Past President of the Auburn University Athletic Development Council.

"I'm truly humbled to be honored by such an impactful organization, whose endeavors have made a difference in children's lives for over 70 years," stated Lee. "The research supported by the March of Dimes has led to dramatic reductions in the numbers of premature births, birth defects, and infant mortalities over the years and Buffalo Rock is proud to be a small part of that success."
